Reagent Preparation:	 Samples - Please predict the concentration before assaying. If concentrations are unknown or not within the detection range, a preliminary experiment is recommended to determine the optimal dilution. PBS (pH 7.0-7.2) or 0.9% physiological saline can be used as dilution buffer. Wash solution - Dilute 10mL of wash solution concentrate (100×) with 990mL of deionized or distilled water to prepare 1000mL of wash solution (1×). If crystals have formed in the concentrate, warm to room temperature and mix gently until the crystals have dissolved. The 1× wash solution is stable for 2 weeks at 2-8°C.

Sample Collection:	 Serum: Use a serum separator tube and allow samples to clot for 2 hours at room temperature or overnight at 2-8°C. Centrifuge at approximately 1000 × g (or 3000rpm) for 15 minutes. Remove serum and assay immediately or aliquot and store samples at -20°C or - 80°C.
	 Plasma: Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge samples for 15 minutes at 100 × g (or 3000rpm) at 2-8°C within 30 minutes of collection. Assay immediately or aliquot and store samples at -20°C or -80°C. Tissue homogenates: The preparation of tissue homogenates will vary depending upon tissue type. For this assay, thoroughly rinse tissues in ice-cold PBS (0.02mol/L, pH 7.0-7.2) to remove excess blood and weigh before homogenization. Mince the tissues into small pieces and homogenize them in a certain amount of PBS with a glass homogenizer on ice. Subject the resulting suspension to ultrasonication or to two freeze-thaw cycles to further break down cell membranes. After that, centrifuge for 15 minutes at 1500 × g (or 5000rpm). 	1. Secure the desired number of coated wells in the holder then add 50 μL of Standards or
	Samples to the appropriate well of the antibody pre-coated Microtiter Plate.
	2. Add 50 μ L of Conjugate to each well. Mix well. Complete mixing in this step is important.
	Cover and incubate for 1 hour at 37 °C.
	3. Wash the Microtiter Plate using one of the specified methods indicated below:
	4. Manual Washing: Remove incubation mixture by aspirating contents of the plate into a sink
	or proper waste container. Using a squirt bottle, fill each well completely with wash solution,
	then aspirate contents of the plate into a sink or proper waste container. Repeat this procedure
