- Cover or cap all kit components and store at 2-8°C when not in use.
- Microtiter plates should be allowed to come to room temperature before opening the foil bags. Once the desired number of strips has been removed, immediately reseal the bag with desiccants and store at 2-8°C to maintain plate integrity.
- Samples should be collected in pyrogen/endotoxin-free tubes.
- Samples should be frozen if not analyzed shortly after collection. Avoid multiple freeze-thaw cycles of frozen samples. Thaw completely and mix well prior to analysis.
- When possible, avoid use of badly hemolyzed or lipemic serum. If large amounts of particulate matter are present, centrifuge or filter prior to analysis.

Information on standard material:

Different kits have different standards. For kits detecting proteisn or peptidse, the standards are recombinant proteins or synthetic peptides. For kits detecting small chemical compounds, the standards are synthetic chemical compounds. There are no standards extracted from natural resources. All of our reombinant proteins are expressed in E.coli. The standard are dissolved in PBS with 0.1 % proclin 300 and some other preservatives.

Information on reagents:

The STOP solution is 1M sulphuric acid. The wash buffer is 0.05 % Tween 20 in PBS, pH 7.4. The ELISA kit dose not contain (sodium) azide, thimerosal, 2-mercaptoethanol (2-ME). Part of the reagents contain BSA.

Information on antibodies:

The provided antibodies and their host vary in different kits.

Protocol:	This ELISA kit applies the competitive enzyme immunoassay technique utilizing a monoclonal	
	antibody for the target antigen and a target antigen HRP conjugate. The assay sample and	
	buffer are incubated together with target antigen HRP conjugate in pre-coated plate for one	
	hour. After the incubation period, the wells are decanted and washed five times. The wells are	
	then incubated with a substrate for HRP enzyme. The product of the enzyme-substrate reactio	
	forms a blue colored complex. Finally, a stop solution is added to stop the reaction, which will	
	then turn the solution yellow. The intensity of color is inversely proportional to the target antige	
	concentration since the target antigen from samples and target antigen HRP conjugate	
	compete for the antibody binding site. Since the number of sites is limited, as more sites are

Reagent Preparation:	 Samples - Please predict the concentration before assaying. PBS (pH 7.0-7.2) or 0.9 % physiological saline can be used as dilution buffe Wash solution - Dilute 10 mL of wash solution concentrate (100×) with 990 mL of deionized or distilled water to prepare 1000 mL of wash solution (1×). If crystals have formed in the concentrate, warm to room temperature and mix gently until the crystals have dissolved. The 1× wash solution is stable for 2 weeks at 2-8 °C.

Sample Collection:	• Serum: Use a serum separator tube and allow samples to clot for 2 hours at room temperature or overnight at 2-8 °C. Centrifuge at approximately 1000 x g (or 3000 rpm) for 1 minutes. Remove serum and assay immediately or aliquot and store samples at -20 °C or -8	
	 °C. Plasma: Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge samples for 15 minutes at 100 x g (or 3000 rpm) at 2-8 °C within 30 minutes of collection. Assay immediately or aliquot and store samples at -20 °C or -80 °C. 	
	• Tissue homogenates : The preparation of tissue homogenates will vary depending upon tissue type. - Cell lysates: Cells should be lysed according to the following directions.
 - 1. Adherent cells should be detached with trypsin and then collected by centrifugation.
 Suspension cells can be collected by centrifugation directly.
 - 2. Wash three times in PBS.
 - 3. Resuspend cells in PBS and subject to ultrasonication 3 times. Alternatively, freeze cells at -20 °C. Thaw cells with gentle mixing. Repeat the freeze/thaw cycle 3 times.

Assay Procedure:

Prepare all Standards before starting assay procedure (Please read Reagents Preparation). It is recommended that all Standards and Samples be added in duplicate to the Microtiter Plate.

1. Secure the desired number of coated wells in the holder then add 50 μ L of Standards or

Samples to the appropriate well of the antibody pre-coated Microtiter Plate.

2. Add 50 μL of Conjugate to each well. Mix well. Complete mixing in this step is important.

Cover and incubate for 1 hour at 37 $^{\circ}\text{C}.$

3. Wash the Microtiter Plate using one of the specified methods indicated below:

4. Manual Washing: Remove incubation mixture by aspirating contents of the plate into a sink or proper waste container. Using a squirt bottle, fill each well completely with wash solution,

then aspirate contents of the plate into a sink or proper waste container. Repeat this procedure

four more times for a total of FIVE washes. After final wash, invert plate, and blot dry by hitting plate onto absorbent paper or paper towels until no moisture appears.

Note: Hold the sides of the plate frame firmly hen washing the plate to assure that all strips remain securely in frame.

5. Automated Washing: Aspirate all wells, and then wash plate FIVE times using wash solution.

	axis against the concentration on the horizontal (X) axis and draw a best fit curve using
	graph paper or statistical software to generate a four parameter logistic (4-PL) curve fit or
	logit log linear regression curve. An x-axis for the optical density and a y-axis for the
	concentration is also a choice. The data may be linearized by plotting the log of the
	concentrations versus the log of the O.D. and the best fit line can be determined by
	regression analysis.
