- The coefficient of determination of the standard curve should be higher or equal 0.95 and the highest O.D. should be more than 1.0.
- Cover or cap all kit components and store at 2-8°C when not in use.
- Microtiter plates should be allowed to come to room temperature before opening the foil bags. Once the desired number of strips has been removed, immediately reseal the bag with desiccants and store at 2-8°C to maintain plate integrity.
- Samples should be collected in pyrogen/endotoxin-free tubes.
- Samples should be frozen if not analyzed shortly after collection. Avoid multiple freeze-thaw cycles of frozen samples. Thaw completely and mix well prior to analysis.

### Information on standard material:

Different kits have different standards. For kits detecting proteisn or peptidse, the standards are recombinant proteins or synthetic peptides. For kits detecting small chemical compounds, the standards are synthetic chemical compounds. There are no standards extracted from natural resources. All of our reombinant proteins are expressed in E.coli. The standard are dissolved in PBS with 0.1 % proclin 300 and some other preservatives.

### Information on reagents:

The STOP solution is 1M sulphuric acid. The wash buffer is 0.05 % Tween 20 in PBS, pH 7.4. The ELISA kit dose not contain (sodium) azide, thimerosal, 2-mercaptoethanol (2-ME). Part of the reagents contain BSA.

Information on antibodies:

The provided antibodies and their host vary in different kits.

Protocol:	This ELISA kit applies the competitive enzyme immunoassay technique utilizing a monoclonal
	antibody for the target antigen and a target antigen HRP conjugate. The assay sample and
	buffer are incubated together with target antigen HRP conjugate in pre-coated plate for one
	hour. After the incubation period, the wells are decanted and washed five times. The wells are
	then incubated with a substrate for HRP enzyme. The product of the enzyme-substrate reactior
	forms a blue colored complex. Finally, a stop solution is added to stop the reaction, which will
	then turn the solution yellow. The intensity of color is inversely proportional to the target antiger
	concentration since the target antigen from samples and target antigen HRP conjugate
	compete for the antibody binding site. Since the number of sites is limited, as more sites are
	occupied by the target antigen from the sample, fewer sites are left to bind the conjugate. A

	Tissue homogenates: The preparation of tissue homogenates will vary depending upon
	tissue type. For this assay, thoroughly rinse tissues in ice-cold PBS (0.02 Mol/L, pH 7.0-7.2) to
	remove excess blood and weigh before homogenization. Mince the tissues into small pieces
	and homogenize them in a certain amount of PBS with a glass homogenizer on ice. Subject the resulting suspension to ultrasonication or to two freeze-thaw cycles to further break

Remove the supernate and assay immediately or aliquot and store samples at -20 °C or -80 °C.

- Cell lysates: Cells should be lysed according to the following directions.
  - 1. Adherent cells should be detached with trypsin and then collected by centrifugation.
     Suspension cells can be collected by centrifugation directly.
  - 2. Wash three times in PBS.
  - 3. Resuspend cells in PBS and subject to ultrasonication 3 times. Alternatively, freeze cells at -20 °C. Thaw cells with gentle mixing. Repeat the freeze/thaw cycle 3 times.
  - 4. Centrifuge at 1000 x g (or 3000 rpm) for 15 minutes at 2-8 °C to remove cellular debris.

- Cell culture supernatants and other body fluids: Centrifuge cell culture media at 1000 x g (or 3000 rpm) for 15 minutes to remove debris. Assay immediately or store samples at -20 °C or -80 °C.

#### Note:

Secure the desired number of coated wells in the holder then add 50 µL of Standards or<br/>Samples to the appropriate well of the antibody pre-coated Microtiter Plate.<br/>2. Add 50 µL of Conjugate to each well. Mix well. Complete mixing in this step is important.<br/>Cover and incubate for 1 hour at 37 °C.<br/>3. Wash the Microtiter Plate using one of the specified methods indicated below:<br/>4. Manual Washing: Remove incubation mixture by aspirating contents of the plate into a sink<br/>or proper waste container. Using a squirt bottle, fill each well completely with wash solution,<br/>then aspirate contents of the plate into a sink or proper waste container. Repeat this procedure<br/>four more times for a total of FIVE washes.
