Application Notes:	 The supplier is only responsible for the kit itself, but not for the samples consumed during the assay. The user should calculate the possible amount of samples used in the whole test. Please reserve sufficient amounts of samples in advance. Please predict the concentration before assaying. If values for these are not within the range of the standard curve, users must determine the optimal sample dilutions for their particular experiments. If the samples are not indicated in the manual, a preliminary experiment to determine the validity of the kit is necessary. Information on standard material:

Different kits have different standards. For kits detecting proteisn or peptidse, the standards are recombinant proteins or synthetic peptides. For kits detecting small chemical compounds, the standards are synthetic chemical compounds. There are no standards extracted from natural resources. All of our reombinant proteins are expressed in E.coli. The standard are dissolved in PBS with 0.1 % proclin 300 and some other preservatives.

Information on reagents:

The STOP solution is 1M sulphuric acid. The wash buffer is 0.05 % Tween 20 in PBS, pH 7.4. The ELISA kit dose not contain (sodium) azide, thimerosal, 2-mercaptoethanol (2-ME). Part of the reagents contain BSA.

Reagent Preparation:	 Samples - Please predict the concentration before assaying. If concentrations are unknown or not within the detection range, a preliminary experiment is recommended to determine the optimal dilution. PBS (pH 7.0-7.2) or 0.9 % physiological saline can be used as dilution buffer. Wash solution - Dilute 10 mL of wash solution concentrate (100×) with 990 mL of deionized or distilled water to prepare 1000 mL of wash solution (1×). If crystals have formed in the concentrate, warm to room temperature and mix gently until the crystals have dissolved. The 1× wash solution is stable for 2 weeks at 2-8 °C.

If samples are to be run within 24 hours, they may be stored at 2-8 °C. Avoid repeated freeze-thaw cycles. Prior to assay, the frozen sample should be brought to room temperature slowly and mixed gently. Tissue or cell extraction samples prepared by chemical lysis buffer may cause unexpected ELISA results due to the impacts of certain chemicals. Samples containing a visible precipitate must be clarified prior to use in the assay. Care should be taken to minimize hemolysis. Do not use grossly hemolyzed or lipemic specimens.
Assay Procedure:	Prepare all Standards before starting assay procedure (Please read Reagents Preparation). It is
	recommended that all Standards and Samples be added in duplicate to the Microtiter Plate.
	1. Secure the desired number of coated wells in the holder then add 50 μL of Standards or
	Samples to the appropriate well of the antibody pre-coated Microtiter Plate.
	2. Add 50 μ L of Conjugate to each well. Mix well. Complete mixing in this step is important.
	Cover and incubate for 1 hour at 37 °C.
	3. Wash the Microtiter Plate using one of the specified methods indicated below:
	4. Manual Washing: Remove incubation mixture by aspirating contents of the plate into a sink
	or proper waste container. Using a squirt bottle, fill each well completely with wash solution,
	then aspirate contents of the plate into a sink or proper waste container. Repeat this procedure
	four more times for a total of FIVE washes. After final wash, invert plate, and blot dry by hitting
	plate onto absorbent paper or paper towels until no moisture appears.
