Information on standard material:

Different kits have different standards. For kits detecting proteisn or peptidse, the standards are recombinant proteins or synthetic peptides. For kits detecting small chemical compounds, the standards are synthetic chemical compounds. There are no standards extracted from natural resources. All of our reombinant proteins are expressed in E.coli. The standard are dissolved in PBS with 0.1 % proclin 300 and some other preservatives.

Information on reagents:

The STOP solution is 1M sulphuric acid. The wash buffer is 0.05 % Tween 20 in PBS, pH 7.4. The ELISA kit dose not contain (sodium) azide, thimerosal, 2-mercaptoethanol (2-ME). Part of the reagents contain BSA.

Information on antibodies:

The provided antibodies and their host vary in different kits.

Plate:	Strips (12 x 8)		
Protocol:	This ELISA kit applies the competitive enzyme immunoassay technique utilizing a monoclonal		
	antibody for the target antigen and a target antigen HRP conjugate. The assay sample and		
	buffer are incubated together with target antigen HRP conjugate in pre-coated plate for one		
	hour. After the incubation period, the wells are decanted and washed five times. The wells are		
	then incubated with a substrate for HRP enzyme. The product of the enzyme-substrate reactio		
	forms a blue colored complex. Finally, a stop solution is added to stop the reaction, which will		
	then turn the solution yellow. The intensity of color is inversely proportional to the target antige		
	concentration since the target antigen from samples and target antigen HRP conjugate		
	compete for the antibody binding site. Since the number of sites is limited, as more sites are		
	occupied by the target antigen from the sample, fewer sites are left to bind the conjugate. A		
	standard curve is plotted relating the intensity of the color (0.D.) to the concentration of		
	standards. The target antigen concentration in each sample is interpolated from this standard		
	curve.		
Reagent Preparation:	 Samples - Please predict the concentration before assaying. If concentrations are unknown or not within the detection range, a preliminary experiment is recommended to determine the optimal dilution. PBS (pH 7.0-7.2) or 0.9 % physiological saline can be used as dilution buffer. Wash solution - Dilute 10 mL of wash solution concentrate (100×) with 990 mL of deionized or distilled water to prepare 1000 mL of wash solution (1×). If crystals have formed in the concentrate, warm to room temperature and mix gently until the crystals have dissolved. The 1× wash solution is stable for 2 weeks at 2-8 °C. 		
	Note:		
	 Bring all kit components and samples to room temperature (20-25 °C) before use. Do not dilute other ready-to-use components. 		
Sample Collection:	• Serum: Use a serum separator tube and allow samples to clot for 2 hours at room temperature or overnight at 2-8 °C. Centrifuge at approximately 1000 x g (or 3000 rpm) for 1 minutes. Remove serum and assay immediately or aliquot and store samples at -20 °C or -8		
	 °C. Plasma: Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge samples for 15 minutes at 100 x g (or 3000 rpm) at 2-8 °C within 30 minutes of collection. Assay immediately or aliquot and store samples at -20 °C or -80 °C. 		
	• Tissue homogenates : The preparation of tissue homogenates will vary depending upon tissue type. For this assay, thoroughly rinse tissues in ice-cold PBS (0.02 Mol/L, pH 7.0-7.2) tremove excess blood and weigh before homogenization. Mince the tissues into small pieces and homogenize them in a certain amount of PBS with a glass homogenizer on ice. Subject the resulting suspension to ultrasonication or to two freeze-thaw cycles to further break down cell membranes. After that, centrifuge for 15 minutes at 1500 x g (or 5000 rpm).

- Cell lysates: Cells should be lysed according to the following directions.
 - 1. Adherent cells should be detached with trypsin and then collected by centrifugation.
 Suspension cells can be collected by centrifugation directly.
 - 2. Wash three times in PBS.
 - 3. Resuspend cells in PBS and subject to ultrasonication 3 times. Alternatively, freeze cells at -20 °C. Thaw cells with gentle mixing. Repeat the freeze/thaw cycle 3 times.
 - 4. Centrifuge at 1000 x g (or 3000 rpm) for 15 minutes at 2-8 °C to remove cellular debris.
 - $\circ~$ 5. Assay immediately or store samples at -20 °C or -80 °C.
- Cell culture supernatants and other body fluids: Centrifuge cell culture media at 1000 x g (or 3000 rpm) for 15 minutes to remove debris. Assay immediately or store samples at -20 °C or -80 °C.

Note:

- Samples should be aliquoted and must be stored at -20 °C (lower or equal 3 months) or -80 °C (lower or equal 6 months) to avoid loss of bioactivity and contamination. If samples are to be run within 24 hours, they may be stored at 2-8 °C. Avoid repeated freeze-thaw cycles.
- Prior to assay, the frozen sample should be brought to room temperature slowly and mixed gently.
- Tissue or cell extraction samples prepared by chemical lysis buffer may cause unexpected ELISA results due to the impacts of certain chemicals.
- Samples containing a visible precipitate must be clarified prior to use in the assay. Care should be taken to minimize hemolysis. Do not use grossly hemolyzed or lipemic specimens.
- Do not use heat-treated specimens.

Assay Procedure:

Prepare all Standards before starting assay procedure (Please read Reagents Preparation). It is recommended that all Standards and Samples be added in duplicate to the Microtiter Plate.

1. Secure the desired number of coated wells in the holder then add 50 μ L of Standards or

Samples to the appropriate well of the antibody pre-coated Microtiter Plate.

2. Add 50 μL of Conjugate to each well. Mix well. Complete mixing in this step is important.

Cover and incubate for 1 hour at 37 $^{\circ}\text{C}.$

3. Wash the Microtiter Plate using one of the specified methods indicated below:

4. Manual Washing: Remove incubation mixture by aspirating contents of the plate into a sink or proper waste container. Using a squirt bottle, fill each well completely with wash solution,

then aspirate contents of the plate into a sink or proper waste container. Repeat this procedure

four more times for a total of FIVE washes. After final wash, invert plate, and blot dry by hitting plate onto absorbent paper or paper towels until no moisture appears.

Note: Hold the sides of the plate frame firmly hen washing the plate to assure that all strips remain securely in frame.

5. Automated Washing: Aspirate all wells, and then wash plate FIVE times using wash solution.
