Comment:

Sample Volume: 50 µL Assay Time: 1.5 h Plate[.] Pre-coated Reagent Preparation: Samples - Please predict the concentration before assaying. If concentrations are unknown or not within the detection range, a preliminary experiment is recommended to determine the optimal dilution. - 4. Centrifuge at 1000 x g (or 3000 rpm) for 15 minutes at 2-8 °C to remove cellular debris.
- 5. Assay immediately or store samples at -20 °C or -80 °C.
- Cell culture supernatants and other body fluids: Centrifuge cell culture media at 1000 x g (or 3000 rpm) for 15 minutes to remove debris. Assay immediately or store samples at -20 °C or -80 °C.

Note:

- Samples should be aliquoted and must be stored at -20 °C (lower or equal 3 months) or -80 °C (lower or equal 6 months) to avoid loss of bioactivity and contamination. If samples are to be run within 24 hours, they may be stored at 2-8 °C. Avoid repeated freeze-thaw cycles.

Always adjust your washer to aspirate as much liquid as possible and set fill volume at 350 μ L/well/wash (range: 350-400 µL). After final wash, invert plate, and blot dry by hitting plate onto absorbent paper or paper towels until no moisture appears. 	 logit log linear regression curve. An x-axis for the optical density and a y-axis for the concentration is also a choice. The data may be linearized by plotting the log of the concentrations versus the log of the 0.D. and the best fit line can be determined by regression analysis. Calculate the concentration of samples corresponding to the mean absorbance from the standard curve.
