	plate provided in this kit has been pre-coated with FGA. Standards or samples are added to the
	appropriate microtiter plate wells with Horseradish Peroxidase (HRP) conjugated antibody
	preparation specific for FGA. The competitive inhibition reaction is launched between with pre-
	coated FGA and FGA in samples. A substrate solution is added to the wells and the color
	develops in opposite to the amount of FGA in the sample. The color development is stopped
	and the intensity of the color is measured.
Reagent Preparation:	<ul> <li>Biotin-antibody (1×) - Centrifuge the vial before opening.</li> <li>Biotin-antibody requires a 100-fold dilution. The suggested dilution is 10µL of Biotin-antibod</li> <li>+ 990µL of Biotin-antibody Diluent.</li> </ul>
	• <b>HRP-avidin (1×)</b> - Centrifuge the vial before opening.



	<ul> <li>Wash Buffer (1×) - If crystals have formed in the concentrate, warm up to room temperature and mix gently until the crystals have completely dissolved. Dilute 20mL of Wash Buffer Concentrate (25×) into deionized or distilled water to prepare 500mL of Wash Buffer (1×).</li> <li>Standard - Centrifuge the standard vial at 6000-10000rpm for 30s.</li> </ul>
	Reconstitute the Standard with 1ml of Sample Diluent. Do not substitute other diluents. This reconstitution produces a stock solution. Mix the standard to ensure complete reconstitution and allow the standard to sit for a minimum of 15 minutes with gentle agitation prior to making dilutions.
