| Comment: | <ul> <li>It is recommended that all standards, controls and samples be run in duplicate. Standards and samples must be assayed at the same time.</li> <li>The coefficient of determination of the standard curve should be a 0.95 and the highest 0.D. should be more than 1.0.</li> <li>Cover or cap all kit components and store at 2-8 °C when not in use.</li> <li>Microtiter plates should be allowed to come to room temperature before opening the foil bags. Once the desired number of strips has been removed, immediately reseal the bag with desiccants and store at 2-8 °C to maintain plate integrity.</li> <li>Samples should be collected in pyrogen/endotoxin-free tubes.</li> <li>Samples should be frozen if not analyzed shortly after collection. Avoid multiple freeze-thaw cycles of frozen samples. Thaw completely and mix well prior to analysis.</li> <li>When possible, avoid use of badly hemolyzed or lipemic serum. If large amounts of particulate matter are present, centrifuge or filter prior to analysis.</li> <li>When pipetting reagents, maintain a consistent order of addition from well-to-well. Information on standard material:

Different kits have different standards. For kits detecting proteisn or peptidse, the standards are recombinant proteins or synthetic peptides. For kits detecting small chemical compounds, the standards are synthetic chemical compounds. There are no standards extracted from natural resources. All of our reombinant proteins are expressed in E.coli. The standard are dissolved in PBS with 0.1 % proclin 300 and some other preservatives.

#### Information on reagents:

The STOP solution is 1M sulphuric acid. The wash buffer is 0.05 % Tween 20 in PBS, pH 7.4. The ELISA kit dose not contain (sodium) azide, thimerosal, 2-mercaptoethanol (2-ME). Part of the reagents contain BSA.
