

Handling


Buffer:	PBS, 0.02 % sodium azide, 0.1 % BSA.
Preservative:	Sodium azide
Precaution of Use:	This product contains Sodium azide: a POISONOUS AND HAZARDOUS SUBSTANCE which should be handled by trained staff only.
Handling Advice:	Avoid repeat freeze-thaw cycles.
Storage:	4 °C,-20 °C
Storage Comment:	Short term: 4°C. Long term: Store at -20°C. Avoid freeze-thaw cycles.
