	specific for sRANKL has been pre-coated onto a microplate. Standards and samples are
	pipetted into the wells and any sRANKL present is bound by the immobilized antibody. After
	removing any unbound substances, a biotin-conjugated antibody specific for sRANKL is added
	to the wells. After washing, avidin conjugated Horseradish Peroxidase (HRP) is added to the
	wells. Following a wash to remove any unbound avidin-enzyme reagent, a substrate solution is

	initial step. The color development is stopped and the intensity of the color is measured.
Reagent Preparation:	 Biotin-antibody (1×) - Centrifuge the vial before opening. Biotin-antibody requires a 100-fold dilution. The suggested dilution is 10µL of Biotin-antibody + 990µL of Biotin-antibody Diluent. HRP-avidin (1×) - Centrifuge the vial before opening. HRP-avidin requires a 100-fold dilution. The suggested dilution is 10µL of HRP-avidin + 990µ of HRP-avidin Diluent. Wash Buffer (1×) - If crystals have formed in the concentrate, warm up to room temperature and mix gently until the crystals have completely dissolved. Dilute 20mL of Wash Buffer Concentrate (25×) into deionized or distilled water to prepare 500mL of Wash Buffer (1×). Standard - Centrifuge the standard vial at 6000-10000rpm for 30s. Reconstitute the Standard with 1ml of Sample Diluent. Do not substitute other diluents. This reconstitution produces a stock solution. Mix the standard to ensure complete reconstitutio and allow the standard to sit for a minimum of 15 minutes with gentle agitation prior to making dilutions. Pipette 250µL of Sample Diluent into each tube. Use the stock solution to produce a 2-fold dilution series. Mix each tube thoroughly before the next transfer. The undiluted Standard serves as the birb standard. Sample Diluent serves as the zero standard (0nn/ml.)
	serves as the high standard. Sample Diluent serves as the zero standard (0ng/mL).


