Use only the reagents supplied by manufacturer.</li> <li>Protect all reagents from strong light during storage and incubation. All the bottle caps of reagents should be covered tightly to prevent the evaporation and contamination of microorganism.</li> <li>There may be some foggy substance in the wells when the plate is opened at the first time. It will not have any effect on the final assay results. Do not remove microtiter plate from the storage bag until needed.</li> <li>Wrong operations during the reagents preparation and loading, as well as incorrect parameter setting for the plate reader may lead to incorrect results. A microplate plate reader with a bandwidth of 10mm or less and an optical density range of 0-3 0.D. or greater at 450 ± 10mm wavelength is acceptable for use in absorbance measurement. Reagent Preparation:	<ul> <li>Bring all kit components and samples to room temperature (18-25°C) before use.</li> <li>Standard - Reconstitute the Standard with the Standard Diluent, keep at room temperature for 10 min and shake gently (not to foam). Prepare tubes containing Standard Diluent to produce a double dilution series.</li> <li>Assay Diluent A and Assay Diluent B - Dilute 6mL of Assay Diluent A or B Concentrate(2×) with 6mL of deionized or distilled water to prepare 12 mL of Assay Diluent A or B. (In fact, more than 6mL Assay Diluent A and Assay Diluent a more than 6mL Assay Diluent A and Assay Diluent B are contained in the bottles. Therefore, in every test, please precisely pipette required amount of Diluent and make double dilution in a new container. The prepared working dilution cannot be frozen.)</li> <li>Detection Reagent A and Detection Reagent B - Briefly spin or centrifuge the stock Detection A and Detection B before use. Sample Collection:	<b>Serum:</b> Allow samples to clot for two hours at room temperature or overnight at 4°C before centrifugation for 20 minutes at approximately 1000 × g. Assay immediately or store samples in aliquot at -20°C or -80°C. Avoid repeated freeze/thaw cycles.
	<b>Plasma:</b> Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge samples for 15 minutes at 1000 × g within 30 minutes of collection. Remove plasma and assay immediately c

store samples in aliquot at -20°C or -80°C. Avoid repeated freeze/thaw cycles.

**Biological Fluids:** Centrifuge samples for 20 minutes at  $1000 \times g$ . Remove particulates and assay immediately or store samples in aliquot at -20 °C or -80 °C for later use. Avoid repeated freeze/thaw cycles.

	<ul><li>validity of the kit is necessary.</li><li>Tissue or cell extraction samples prepared by chemical lysis buffer may cause unexpected</li></ul>
	<ul> <li>ELISA results due to the impacts from certain chemicals.</li> <li>Due to the possibility of mismatching between antigen from other origin and antibody used i our kits (e.g.,antibody targets conformational epitope rather than linear epitope), some native or recombinant proteins from other manufacturers may not be recognized by our products.</li> <li>Influenced by the factors including cell viability, cell number or sampling time, samples from cell culture supernatant may not be detected by the kit.</li> <li>Fresh samples without long time storage is recommended for the test. Otherwise, protein degradation and denaturalization may occur in those samples and finally lead to wrong results.</li> </ul>
Assay Procedure:	<ul> <li>1. Determine wells for diluted standard, blank and sample. Prepare wells for standard points, 1 well for blank. Add dilutions of standard (read Reagent Preparation), blank and samples into the appropriate wells, respectively. You might now need to incubate at 37 °C. And then add Detection Reagent A to each well. You might need to incubate at 37 °C again.</li> <li>2. Aspirate the solution and wash with 350 µL of 1X Wash Solution to each well using a squir bottle, multi-channel pipette, manifold dispenser or autowasher, and let it sit for 1-2 minutes. Remove the remaining liquid from all wells completely by snapping the plate onto absorbent paper. Repeat 3 times. After the last wash, remove any remaining Wash Buffer by aspirating</li> </ul>
	<ul> <li>or decanting. Invert the plate and blot it against absorbent paper.</li> <li>3. Add 100 µL of Detection Reagent B working solution to each well. Incubate for 30 minutes</li> </ul>
	at 37 °C after covering it with the Plate sealer.
	• 4. Repeat the aspiration/wash process for total 5 times as conducted in step 2.
	<ul> <li>5. Add 90 µL of Substrate Solution to each well. Cover with a new Plate sealer. Incubate for 15 - 25 minutes at 37 °C (Don't exceed 30 minutes). Protect from light. The liquid will turn blue by the addition of Substrate Solution.</li> </ul>
	<ul> <li>6. Add 50 μL of Stop Solution to each well. The liquid will turn yellow by the addition of Stop</li> </ul>
	solution. Mix the liquid by tapping the side of the plate. If color change does not appear uniform, gently tap the plate to ensure thorough mixing.

 7. Remove any drop of water and fingerprint on the bottom of the plate and confirm there is no bubble on the surface of the liquid. Then, run the microplate reader and conduct measurement at 450 nm immediately.

#### Note:

- 1. Assay preparation: Keep appropriate numbers of wells for each experiment and remove extra wells from microplate. Rest wells should be resealed and stored at -20 °C.
  2. Samples or reagents addition: Please use the freshly prepared Standard. Please carefully add samples to wells and mix gently to avoid foaming. Do not touch the well wall. For each step in the procedure, total dispensing time for addition of reagents or samples to the assay plate should not exceed 10 minutes. This will ensure equal elapsed time for each pipetting step, without interruption. To avoid cross-contamination, change pipette tips between additions of standards, samples, and reagents. Also, use separated reservoirs for each reagent.
- 3. Incubation: To ensure accurate results, proper adhesion of plate sealers during incubation steps is necessary. Do not allow wells to sit uncovered for extended periods between incubation steps. Once reagents are added to the well strips, DO NOT let the strips DRY at any time during the assay. Incubation time and temperature must be controlled.
- 4. Washing: The wash procedure is critical. Complete removal of liquid at each step is
  essential for good performance. After the last wash, remove any remaining Wash Solution by
  aspirating or decanting and remove any drop of water and fingerprint on the bottom of the
  plate. Insufficient washing will result in poor precision and false elevated absorbance
  reading.
- 5. Controlling of reaction time: Observe the change of color after adding TMB Substrate (e.g. observation once every 10 minutes), if the color is too deep, add Stop Solution in advance to avoid excessively strong reaction which will result in inaccurate absorbance reading.
- 6. TMB Substrate is easily contaminated. Please protect it from light.
- 7. The environment humidity which is less than 60 % might have some effects on the final performance, therefore, a humidifier is recommended to be used at that condition.

Calculation of Results:	Average the duplicate readings for each standard, control, and samples and subtract the
	average zero standard optical density. Construct a standard curve by plotting the mean O.D.
	and concentration for each standard and draw a best fit curve through the points on the graph
	or create a standard curve on log-log graph paper with the target concentration on the y-axis
	and absorbance on the x-axis. Draw the best fit straight line through the standard points and it
	can be determined by regression analysis. Using some plot software, for instance, curve expert
	1.30, is also recommended. If samples have been diluted, the concentration read from the
	standard curve must be multiplied by the dilution factor.
Assay Precision:	Intra-assay Precision (precision within an assay): Three samples with low, medium and high
	levels of the target antigen were tested twenty times on one plate, respectively.

Inter-assay Precision (precision between assays): Three samples with low, medium and high

I is also strongly suggested that the whole assay is performed by the same operator from the beginning to the end.
Storage:	4 °C/-20 °C
Storage Comment:	<ul> <li>For unopened kit: All the reagents should be kept according to the labels on vials. The Standard, Detection Reagent A, Detection Reagent B and the 96-well strip plate should be stored at -20°C upon receipt while the others should be at 4°C.</li> <li>For opened kit: When the kit is opened, the remaining reagents still need to be stored according to the above storage condition. Besides, please return the unused wells to the foil pouch containing the desiccant pack, and reseal along entire edge of zip-seal. Note: It is highly recommended to use the remaining reagents within 1 month provided this is within the expiration date of the kit.</li> <li>For ELISA kit, 1 day storage at 37°C can be considered as 2 months at 4°C, which means 3 days at 37°C equaling 6 months at 4°C.</li> </ul>
