	processes (including the cell cycle, immune response, signaling cascades and developmental
	processes) through the targeting of proteins, such as cyclins, cyclin-dependent kinase
	inhibitors, IkB-a and b-catenin, for degradation by the proteasome after ubiquitination. Via its F-
	box domain, FBXO15 can directly interact with Skp1 p19 and CUL-1. In addition, FBXO15 is a
	target of the transcription factor Oct-3/4, however, it does not appear to be essential for early
	development and fertility.
