Information on standard material:

Different kits have different standards. For kits detecting proteisn or peptidse, the standards are recombinant proteins or synthetic peptides. For kits detecting small chemical compounds, the standards are synthetic chemical compounds. There are no standards extracted from natural resources. All of our reombinant proteins are expressed in E.coli. The standard are dissolved in PBS with 0.1 % proclin 300 and some other preservatives.

Information on reagents:

The STOP solution is 1M sulphuric acid. The wash buffer is 0.05 % Tween 20 in PBS, pH 7.4. The ELISA kit dose not contain (sodium) azide, thimerosal, 2-mercaptoethanol (2-ME). Part of the reagents contain BSA.

Information on antibodies:

The provided antibodies and their host vary in different kits.

Reagent Preparation:	• <b>Samples</b> - Please predict the concentration before assaying. If concentrations are unknown
	or not within the detection range, a preliminary experiment is recommended to determine the optimal dilution. PBS (pH 7.0-7.2) or 0.9% physiological saline can be used as dilution buffer.
	<ul> <li>Wash solution - Dilute 10mL of wash solution concentrate (100x) with 990mL of deionized or</li> </ul>
	distilled water to prepare 1000mL of wash solution (1×). If crystals have formed in the
	concentrate, warm to room temperature and mix gently until the crystals have dissolved. The
	1× wash solution is stable for 2 weeks at 2-8°C.

	Bring all kit components and samples to room temperature (20-25°C) before use.

Sample Collection:	Serum: Use a serum separator tube and allow samples to clot for 2 hours at room

	• Plasma: Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge samples for

	Tissue homogenates: The preparation of tissue homogenates will vary depending upon

	remove excess blood and weigh before homogenization. Mince the tissues into small pieces
	and homogenize them in a certain amount of PBS with a glass homogenizer on ice. Subject

- Samples should be aliquoted and must be stored at -20°C (lower or equal 3 months) or -80°C (lower or equal 6 months) to avoid loss of bioactivity and contamination. If samples are to be run within 24 hours, they may be stored at 2-8°C. Avoid repeated freeze-thaw cycles.

#### Sodium azide

#### Precaution of Use:

- This kit contains a small amount of 3, 3', 5, 5'-Tetramethylbenzidine (TMB) in Substrate B. TMB is non-carcinogenic but it is hazardous in case of skin contact, eye contact, ingestion and inhalation. In case of contact, rinse affected area with plenty of water.
- The stop solution provided with this kit is an acid solution. Wear protective gloves, clothing, and face protection.
