Note: 1. Samples to be used within 5 days may be stored at 2-8 °C, otherwise samples must stored at -20 °C (1 month) or -80 °C (2 months) to avoid loss of bioactivity and contamination. 2. Tissue or cell extraction samples prepared by chemical lysis buffer may cause unexpected ELISA results due to the impacts of certain chemicals. 3. Influenced by the factors including cell viability, cell number and also sampling time, samples from cell culture supernatant may not be detected by the kit 4. Sample hemolysis will influence the result, so hemolytic specimen can not be detected. 5. When performing the assay slowly bring samples to room temperature. Assay Procedure: Allow all reagents to reach room temperature (Please do not dissolve the reagents at 37 °C directly.). All the reagents should be mixed thoroughly by gently swirling before pipetting. Avoid foaming. Keep appropriate numbers of strips for 1 experiment and remove extra strips from microtiter plate. Removed strips should be resealed and stored at 4 °C until the kits expiry date. Prepare all reagents, working standards and samples as directed in the previous sections. Please predict the concentration before assaying. If values for these are not within the range of the standard curve, users must determine the optimal sample dilutions for their particular experiments. 1. Add 50 µL of Standard, Blank, or Sample per well. 2. Immediately add 50 µL of Detection A working solution to each well. Cover with the Plate sealer. Gently tap the plate to ensure thorough mixing. Incubate for 1 hour at 37 °C.

- 3. Aspirate each well and wash, repeating the process three times for a total of three washes. Wash by filling each well with Wash Buffer (approximately 400 μL) using a squirt bottle, multichannel pipette, manifold dispenser or autowasher and let it sit for 1~2 minutes. Complete removal of liquid at each step is essential to good performance. After the last wash, remove any remaining Wash Buffer by aspirating or decanting. Invert the plate and blot it against clean paper towels.
- 4. Add 100 μ L of Detection Reagent B working solution to each well. Cover with a new Plate sealer. Incubate for 45 minutes at 37 °C.
- 5. Repeat the aspiration/wash process for five times as conducted in step three.
- 6. Add 90 μ L of Substrate Solution to each well. Cover with a new Plate sealer. Incubate within 15-30 minutes at 37 °C. Protect from light.
- 7. Add 50 μ L of Stop Solution to each well. If color change does not appear uniform, gently tap the plate to ensure thorough mixing.
- 8. Determine the optical density of each well at once, using a microplate reader set to 450 nm.

| | Absorbance is a function of the incubation time. Therefore, prior to starting the assay it is recommended that all reagents should be freshly prepared prior to use and all required stripwells are secured in the microtiter frame. This will ensure equal elapsed time for each pipetting step, without interruption. Please carefully reconstitute Standards or working Detection Reagent A and B according to the instruction, and avoid foaming and mix gently until the crystals have completely dissolved. The reconstituted Standards Detection Reagent A and B can be used only once. This assay requires pipetting of small volumes. To minimize imprecision caused by pipetting, ensure that pipettors are calibrated. It is recommended to suck more than 10 μL for once pipetting. To ensure accurate results, proper adhesion of plate sealers during incubation steps is necessary. Do not allow wells to sit uncovered for extended periods between incubation steps. A microtiter plate reader with a bandwidth of 10nm or less and an optical density range of 0-3 0D or greater at 450nm wavelength is acceptable for use in absorbance measurement. 7. Use fresh disposable pipette tips for each transfer to avoid contamination. 8. Do not substitute reagents from one kit lot to another. Use only the reagents supplied by manufacturer. 9. Even the same operator might get different results in two separate experiments. In order to get better reproducible results, the operation of every step in the assay should be controlled. Furthermore, a preliminary experiment before assay for each batch is recommended. 10. Each kit has been strictly passed Q.C test. However, results from different batches might arise from above factors, too. 11. Kits from different manufacturers for the same item might produce different results, since we haven't compared our products with other manufacturers. 12.
