



Flow Cytometry

Image 1. Overlay histogram showing F9 cells stained with (ABIN6243185 and ABIN6577831) (red line). The cells were fixed with 2% paraformaldehyde (10 min) and then permeabilized with 90% methanol for 10 min. The cells were then icubated in 2% bovine serum albumin to block non-specific protein-protein interactions followed by the antibody ((ABIN6243185 and ABIN6577831), 1:25 dilution) for 60 min at 37 °C. The secondary antibody used was Alexa Fluor® 488 goat anti-rabbit IgG (H+L) (1583138) at 1/400 dilution for 40 min at 37 °C. Isotype control antibody (blue line) was rabbit IgG1 (1 μg/1x10^6 cells) used under the same conditions. Acquisition of >10, 000 events was



performed.

Image 2. Western blot analysis of lysate from mouse F9 cell line, using Eras Antibody (N-term) (ABIN6243185 and ABIN6577831). (ABIN6243185 and ABIN6577831) was diluted at 1:1000. A goat anti-rabbit IgG H&L(HRP) at 1:10000 dilution was used as the secondary antibody. Lysate at $20 \, \mu g$.
