Incubate 1 hours at 37 °C,</li> <li>Aspirate and add 100μL prepared Detection Reagent A. Incubate 1 hour at 37 °C,</li> <li>Aspirate and wash 3 times,</li> <li>Add 100μL prepared Detection Reagent B. If the kit will not be used up in one time, please only take out strips and reagents for present experiment, and leave the remaining strips and reagents in required condition.</li> <li>Standard - Reconstitute the Standard with 1.0 mL of Standard Diluent, keep for 10 minutes at room temperature, shake gently (not to foam). The concentration of the standard in the stock solution is 10 ng/mL. Prepare 7 tubes containing 0.5 mL Standard Diluent and produce a double dilution series. Mix each tube thoroughly before the next transfer. 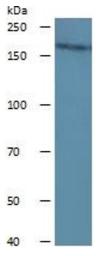

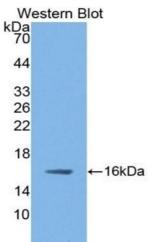

**Image 1.** Rabbit Capture antibody from the kit in WB with Positive Control: Sample Rat Cerebrum lysate.

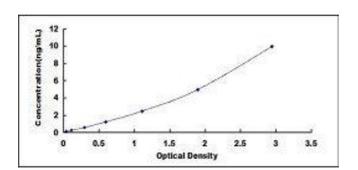
