

	3. Aspirate and add 100µL prepared Detection Reagent A. Incubate 1 hour at 37 °C,
	4. Aspirate and wash 3 times,
	5. Add 100µL prepared Detection Reagent B. Incubate 30 minutes at 37 °C,
	6. Aspirate and wash 5 times,
	7. Add 90µL Substrate Solution. Incubate 10-20 minutes at 37 °C,
	8. Add 50µL Stop Solution. Read at 450nm immediately.
Reagent Preparation:	1. Bring all kit components and samples to room temperature (18-25 °C) before use. If the kit
	will not be used up in one time, please only take out strips and reagents for present
	experiment, and leave the remaining strips and reagents in required condition.
	2. Standard - Reconstitute the Standard with 1.0 mL of Standard Diluent, keep for 10 minutes at
	room temperature, shake gently (not to foam). The concentration of the standard in the stock
	solution is 1,000 ng/mL. Prepare 7 tubes containing 0.5 mL Standard Diluent and produce a
	double dilution series. Mix each tube thoroughly before the next transfer. Set up 7 points of
	diluted standard such as 1,000 ng/mL, 500 ng/mL, 250 ng/mL, 125 ng/mL, 62.5 ng/mL,


- 3. Please carefully reconstitute Standards or working Detection Reagent A and B according to the instruction, and avoid foaming and mix gently until the crystals are completely dissolved. 
