Protocol:	 Prepare all reagents, samples and standards, Add 100μL standard or sample to each well. Incubate 1 hours at 37 °C, Aspirate and add 100μL prepared Detection Reagent A. Incubate 1 hour at 37 °C, Aspirate and wash 3 times, Add 100μL prepared Detection Reagent B. Incubate 30 minutes at 37 °C, Aspirate and wash 5 times, Add 90μL Substrate Solution. Incubate 10-20 minutes at 37 °C, Add 50μL Stop Solution. Read at 450nm immediately.
Reagent Preparation:	 Bring all kit components and samples to room temperature (18-25 °C) before use. If the kit will not be used up in one time, please only take out strips and reagents for present experiment, and leave the remaining strips and reagents in required condition. Standard - Reconstitute the Standard with 1.0 mL of Standard Diluent, keep for 10 minutes at room temperature, shake gently (not to foam). The concentration of the standard in the stock solution is 10 ng/mL. Prepare 7 tubes containing 0.5 mL Standard Diluent and produce a double dilution series. Mix each tube thoroughly before the next transfer. Set up 7 points of diluted standard such as 10 ng/mL, 5 ng/mL, 2.5 ng/mL, 1.25 ng/mL, 0.625 ng/mL, 0.312 ng/mL, 0.156 ng/mL, and the last microcentrifuge tube with Standard Diluent is the blank as 0 ng/mL. Wash Solution - Dilute 20 mL of Wash Solution concentrate (30x) with 580 mL of deionized or distilled water to prepare 600 mL of Wash Solution (1x). TMB substrate - Aspirate the needed dosage of the solution with sterilized tips and do not dump the residual solution into the vial again.


