The standard might be recombinant protein or natural protein, that will depend on the specific
kit. Moreover, the expression system is E.coli or yeast or mammal cell. There is 0.05% proclin
300 in the standard as preservative.
Information on reagents:
The stop solution used in the kit is sulfuric acid with concentration of 1 mol/L. And the wash
solution is TBS. The standard diluent contains 0.02 % sodium azide, assay diluent A and assay
diluent B contain 0.01% sodium azide. Some kits can contain is BSA in them.
Information on antibodies:
The provided antibodies and their host vary in different kits.



	7. Add 90µL Substrate Solution. Incubate 10-20 minutes at 37 °C, 8. Add 50µL Stop Solution. Read at 450nm immediately.	
Reagent Preparation:	<ol> <li>Bring all kit components and samples to room temperature (18-25 °C) before use.</li> <li>Standard - Reconstitute the Standard with 1.0 mL of Standard Diluent, keep for 10 minutes at room temperature, shake gently (not to foam). The concentration of the standard in the stock solution is 16,000pg/mL. Firstly dilute the stock solution to 2,000pg/mL and the diluted standard serves as the highest standard (2,000pg/mL). Then prepare 7 tubes containing 0.5 mL Standard Diluent and use the diluted standard to produce a double dilution series. Mix each tube thoroughly before the next transfer. Set up 7 points of diluted standard such as 2,000pg/mL, 1,000pg/mL, 500pg/mL, 250pg/mL, 125pg/mL, 62.5pg/mL, 31.2pg/mL, and the last microcentrifuge tube with Standard Diluent is the blank as 0pg/mL.</li> <li>Detection Reagent A and Detection Reagent B - Briefly spin or centrifuge the stock Detection A and Detection B before use. Dilute to the working concentrate (30x) with 580 mL of deionized or distilled water to prepare 600 mL of Wash Solution (1x).</li> <li>TMB substrate - Aspirate the needed dosage of the solution with sterilized tips and do not dump the residual solution into the vial again.</li> </ol>
