	• Please estimate the concentration of the samples before performing the test. If the values are not in therange of the standard curve, the optimal sample dilution for the particular experiment has to be determined. Samples should then be diluted with PBS (pH =7.0-7.2).
	Note:
	Serum and plasma samples must be diluted 1/100 with Assay Buffer e.g. 5 $\mu$ L sample + 495 $\mu$ L
	Assay Buffer. Patient samples with a concentration of drug above the measuring range are to
	be rated as > "Highest Standard (Standard A)". The result must not be extrapolated. The patient
	sample in question should be further diluted with Assay Buffer and retested.
Assay Procedure:	1. Dilute samples as described in "Sample preparation".
	<ol> <li>Pipette 100 μL of each of the Standards, Low level Control, High level Control and diluted samples into the respective wells of microtiter plate.</li> </ol>
	3. Cover the plate with plate sealer, briefly mix contents by gently shaking the plate and incubate 60 minutes at room temperature (18-25 °C)
	<ul> <li>4. Remove plate sealer and discard solution. Wash plate three times with 300 µL Wash Buffer.</li> <li>Remove excess solution by tapping the inverted plate on a paper towel.</li> </ul>
	<ol> <li>5. Add 100 μL Conjugate into each well.</li> <li>6. Cover the plate with plate sealer.</li> </ol>
	7. Incubate 30 minutes at room temperature (18-25 °C).
	8. Remove plate sealer and discard solution. Wash plate three times with 300 μL Wash Buffer. Remove excess solution by tapping the inverted plate on a paper towel.
	9. Add 100 µL Substrate into each well.
	10. Incubate 15 minutes without plate sealer at room temperature (18-25 °C) in the dark. 11. Stop the substrate reaction by adding 100 µL Stop Solution into each well. Briefly mix
	contents by gently shaking the plate. Colour changes from blue to yellow.
	12. Measure optical density with a photometer at OD 450nm with reference wavelength 650 nm
	(450/650 nm) within 30 minutes after pipetting the Stop Solution.
Calculation of Results:	• Create a standard curve by using the standards. OD 450/650 nm for each standard on the vertical (Y-axis) axis versus the corresponding drug concentration on the horizontal (X-axis) axis.
	• The concentration of the samples can be read directly from this standard curve. Using the absorbance value for each sample, determine the corresponding concentration of drug from the standard curve.
	<ul> <li>Find the absorbance value on the Y- axis and extend a horizontal line to the curve. At the point of intersection, extend a vertical line to the X-axis and read the drug concentration of the unknown sample.</li> </ul>
	If computer data is going to be used, we recommend primarily "Four Parameter Logistic
	<ul> <li>(4PL)" or secondly the "point-to-point calculation".</li> <li>To obtain the exact values of the samples, the concentration determined from the standard- surve result he resulting in the dilution factor (100v).</li> </ul>


