Different kits have different standards. For kits detecting proteisn or peptidse, the standards are recombinant proteins or synthetic peptides. For kits detecting small chemical compounds, the standards are synthetic chemical compounds. There are no standards extracted from natural resources. All of our reombinant proteins are expressed in E.coli. The standard are dissolved in PBS with 0.1 % proclin 300 and some other preservatives.

#### Information on reagents:

The STOP solution is 1M sulphuric acid. The wash buffer is 0.05 % Tween 20 in PBS, pH 7.4. The ELISA kit dose not contain (sodium) azide, thimerosal, 2-mercaptoethanol (2-ME). Part of the reagents contain BSA.

	<ul> <li>1. Adherent cells should be detached with trypsin and then collected by centrifugation.</li> </ul>

Suspension cells can be collected by centrifugation directly.

- 2. Wash three times in PBS.
- 3. Resuspend cells in PBS and subject to ultrasonication 3 times. Alternatively, freeze cells at -20°C. Thaw cells with gentle mixing. Repeat the freeze/thaw cycle 3 times.
- 4. Centrifuge at 1000 × g (or 3000rpm) for 15 minutes at 2-8°C to remove cellular debris.
- 5. Assay immediately or store samples at -20°C or -80°C.
- Cell culture supernatants and other body fluids: Centrifuge cell culture media at 1000 × g (or 3000rpm) for 15 minutes to remove debris. Assay immediately or store samples at -20°C or -80°C.

All O.D. values are subtracted by the mean value of blank control well.</li> <li>Construct a standard curve by plotting the average O.D. for each standard on the vertical (Y) axis against the concentration on the horizontal (X) axis, and draw a best fit curve using graph paper or statistical software to generate a linear regression, four parameter logistic (4-PL) curve-fit, or curvilinear regression of second degree. An x-axis for the optical density and a y-axis for the concentration is also a choice. The data may be linearized by plotting the log of the concentrations versus the log of the O.D. and the best fit line can be determined by regression analysis.</li> <li>Calculate the concentration of samples corresponding to the mean absorbance from the standard curve.</li> </ul>
	<ul> <li>Note:</li> <li>Any variation in operator, pipetting and washing technique, incubation time/temperature and kit age can cause variation in result.
