All of our reombinant proteins are expressed in E.coli. The standard are dissolved in PBS with 0.1 % proclin 300 and some other preservatives.

- Tissue homogenates: The preparation of tissue homogenates will vary depending upon tissue type. For this assay, thoroughly rinse tissues in ice-cold PBS (0.02mol/L, pH 7.0-7.2) to remove excess blood and weigh before homogenization. Mince the tissues into small pieces and homogenize them in a certain amount of PBS with a glass homogenizer on ice. Subject the resulting suspension to ultrasonication or to two freeze-thaw cycles to further break down cell membranes. After that, centrifuge for 15 minutes at 1500 × g (or 5000rpm). Remove the supernate and assay immediately or aliquot and store samples at -20°C or -80°C.
- Cell lysates: Cells should be lysed according to the following directions.
 - 1. Adherent cells should be detached with trypsin and then collected by centrifugation.
 Suspension cells can be collected by centrifugation directly.
 - 2. Wash three times in PBS.
 - 3. Resuspend cells in PBS and subject to ultrasonication 3 times. Alternatively, freeze cells at -20°C. Thaw cells with gentle mixing. Repeat the freeze/thaw cycle 3 times.

- 4. Centrifuge at 1000 x g (or 3000rpm) for 15 minutes at 2-8°C to remove cellular debris.
- 5. Assay immediately or store samples at -20°C or -80°C.
- Cell culture supernatants and other body fluids: Centrifuge cell culture media at 1000 × g (or 3000rpm) for 15 minutes to remove debris. Assay immediately or store samples at -20°C or -80°C.

Note:

Calculation of Results:

- The standard curve is used to determine the amount of samples.
- First, average the duplicate readings for each standard and sample. All O.D. values are subtracted by the mean value of blank control well.
- Construct a standard curve by plotting the average O.D. for each standard on the vertical (Y) axis against the concentration on the horizontal (X) axis, and draw a best fit curve using graph paper or statistical software to generate a linear regression, four parameter logistic (4-PL) curve-fit, or curvilinear regression of second degree. An x-axis for the optical density and a y-axis for the concentration is also a choice. The data may be linearized by plotting the log of the concentrations versus the log of the O.D. and the best fit line can be determined by regression analysis.
- Calculate the concentration of samples corresponding to the mean absorbance from the standard curve.

Note:
