	sample diluent, antibody diluent, enzyme diluent and standard all contain BSA.

Protocol:	Antibody specific for CD36 has been pre-coated onto a microplate. Standards and samples are pipetted into the wells and any CD36 present is bound by the immobilized antibody. After removing any unbound substances, a biotin-conjugated antibody specific for CD36 is added to the wells. After washing, avidin conjugated Horseradish Peroxidase (HRP) is added to the wells. Following a wash to remove any unbound avidin-enzyme reagent, a substrate solution is added to the wells and color develops in proportion to the amount of CD36 bound in the initial step. The color development is stopped and the intensity of the color is measured.
Reagent Preparation:	<ul> <li>Biotin-antibody (1×) - Centrifuge the vial before opening. Biotin-antibody requires a 100-fold dilution. The suggested dilution is 10µL of Biotin-antibody + 990µL of Biotin-antibody Diluent.</li> <li>HRP-avidin (1×) - Centrifuge the vial before opening. HRP-avidin requires a 100-fold dilution. The suggested dilution is 10µL of HRP-avidin + 990µL of HRP-avidin Diluent.</li> <li>Wash Buffer (1×) - If crystals have formed in the concentrate, warm up to room temperature and mix gently until the crystals have completely dissolved. Dilute 20mL of Wash Buffer (1×).</li> <li>Standard - Centrifuge the standard vial at 6000-10000rpm for 30s. Reconstitute the Standard with 1ml of Sample Diluent. Do not substitute other diluents. This reconstitution produces a stock solution. Mix the standard to ensure complete reconstitution and allow the standard to sit for a minimum of 15 minutes with gentle agitation prior to making dilutions.</li> <li>Pipette 250µL of Sample Diluent into each tube. Use the stock solution to produce a 2-fold dilution series. Mix each tube thoroughly before the next transfer. The undiluted Standard serves as the high standard. Sample Diluent serves as the zero standard (0ng/mL).</li> </ul>
	<ul> <li>Note:</li> <li>Kindly use graduated containers to prepare the reagent. Please don't prepare the reagent directly in the Diluent vials provided in the kit.</li> <li>Bring all reagents to room temperature (18-25°C) before use for 30 min.</li> <li>Prepare fresh standard for each assay. Use within 4 hours and discard after use.</li> <li>Making serial dilution in the wells directly is not permitted.</li> <li>Please carefully reconstitute Standards according to the instruction. Avoid foaming and mix gently until the crystals have completely dissolved. To minimize imprecision caused by pipetting, use small volumes and ensure that pipettors are calibrated. It is recommended to suck more than 10µL when pipetting.</li> </ul>

	• It is recommended to use distilled water to prepare reagents and samples. Using contaminated water or container for reagent preparation will influence detection result.
Sample Collection:	<ul> <li>Serum: Use a serum separator tube (SST) and allow samples to clot for two hours at room temperature or overnight at 4 °C before centrifugation for 15 minutes at 1000 × g. Remove serum and assay immediately or aliquot and store samples at -20 °C or -80 °C. Avoid repeated freeze-thaw cycles.</li> <li>Plasma: Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge for 15 minutes at 1000 × g at 2-8 °C within 30 minutes of collection. Assay immediately or aliquot and store samples at -20 °C or -80 °C. Avoid repeated freeze-thaw cycles.</li> <li>Tissue Homogenates: Rinse 100 mg tissue with 1× PBS, homogenize in 1mL of 1× PBS and store overnight at -20 °C. After two freeze-thaw cycles to break the cell membranes, centrifuge the homogenates for 5 minutes at 5000 × g, 2-8 °C. Remove and assay the supernate immediately. Alternatively, aliquot and store samples at -20 °C or -80 °C. Centrifuge the sample again after thawing before the assay. Avoid repeated freeze-thaw cycles.</li> </ul>
Assay Procedure:	<ul> <li>1. Prepare all reagents, working standards and samples as directed in the respective sections.</li> <li>2. Refer to the Assay Layout Sheet to determine the number of wells to be used and put any remaining wells and the desiccant back into the pouch and seal the ziploc, store unused wells at 4°C.</li> <li>3. Add 100µL of standard or sample per well. Cover with the adhesive strip provided. Incubate for 2 hours at 37°C. A plate layout is provided to record standards and samples assayed.</li> <li>4. Remove the liquid of each well, don't wash.</li> <li>5. Add 100µL of Biotin-antibody (1×) to each well. Cover with a new adhesive strip. Incubate for 1 hour at 37°C. (Biotin-antibody (1×) may appear cloudy. Warm up to room temperature and mix gently until solution appears uniform.)</li> <li>6. Aspirate each well and wash, repeating the process two times for a total of three washes. Wash by filling each well with Wash Buffer (200µL) using a squirt bottle, multi-channel pipette, manifold dispenser or autowasher and let it stand for 2 minutes, complete removal of liquid at each step is essential for good performance. After the last wash, remove any remaining wash Buffer by aspirating or decanting. Invert the plate and blo it against clean paper towels.</li> <li>7. Add 100µL of HRP-avidin (1×) to each well. Cover the microtiter plate with a new adhesive strip. Incubate for 1 hour at 37°C.</li> <li>8. Repeat the aspiration/wash process for five times as in step 6.</li> <li>9. Add 90µL of Stop Solution to each well, gently tap the plate to ensure thorough mixing.</li> <li>10. Add 50µL of Stop Solution to each well, gently tap the plate to ensure thorough mixing.</li> <li>11. Determine the optical density of each well within 5 minutes using a microplate reader set to 450nm. If wavelength correction is available, set to 540nm or 570nm. Subtract readings at 540nm or 570nm from the readings at 450nm. This subtraction will correct for optical</li> </ul>

imperfections in the plate. Readings made directly at 450nm without correction may be higher and less accurate.

Note:

- The experiment's final results will be closely related to validity of the products, operation skills of the end users and the environmental conditions.
- Samples or reagents addition: Please use the freshly prepared Standard. Please carefully add samples to wells and mix gently to avoid foaming. Do not touch the well wall as possible. For each step in the procedure, total dispensing time for addition of reagents or samples to the assay plate should not exced 10 minutes. This will ensure equal elapsed time for each pipetting step, without interruption. Duplication of all standards and specimens, although not required, is recommended. To avoid cross-contamination, change pipette tips between reagent additions. Also, use separate reservoirs for each reagent.
- Incubation: To ensure accurate results, proper adhesion of plate sealers during incubation steps is necessary. Do not allow wells to sit uncovered for extended periods between incubation steps. Once reagents have been added to the well strips, DO NOT let the strips DRY at any time during the assay. Incubation time and temperature must be observed.
- Washing: The wash procedure is critical. Complete removal of liquid at each step is essential for good performance. After the last wash, remove any remaining Wash Solution by aspirating or decanting and remove any drop of water and fingerprint on the bottom of the plate. Insufficient washing will result in poor precision and falsely elevated absorbance reading. When using an automated plate washer, adding a 30 second soak period following the addition of wash buffer and/or rotating the plate 180 degrees between wash steps may improve assay precision.
- Controlling of reaction time: Observe the change of color after adding TMB Substrate (e.g. observation once every 10 minutes), TMB Substrate should change from colorless or light blue to gradations of blue. If the color is too deep, add Stop Solution in advance to avoid excessively strong reaction which will result in inaccurate absorbance reading.
- TMB Substrate is easily contaminated. TMB Substrate should remain colorless or light blue until added to the plate. Please protect it from light.
- Stop Solution should be added to the plate in the same order as the TMB Substrate. The color developed in the wells will turn from blue to yellow upon addition of the Stop Solution.
   Wells that are green in color indicate that the Stop Solution has not mixed thoroughly with the TMB Substrate.

Calculation of Results:	Average the duplicate readings for each standard and sample and subtract the average zero
	standard optical density.
	Create a standard curve by reducing the data using computer software capable of generating a
	four parameter logistic (4-PL) curve fit. As an alternative, construct a standard curve by plotting
	the mean absorbance for each standard on the x-axis against the concentration on the y-axis
	and draw a best fit curve through the points on the graph. The data may be linearized by
	plotting the log of the target antigen concentration versus the log of the O.D. and the best fit line
	can be determined by regression analysis. This procedure will produce an adequate but less

Until all factors have been tested in the Immunoassay, the possibility of interference cannot be excluded.</li> </ul>
