

| Reagent Preparation: | <ul> <li>Biotin-antibody (1×) - Centrifuge the vial before opening.<br/>Biotin-antibody requires a 100-fold dilution. The suggested dilution is 10µL of Biotin-antibody + 990µL of Biotin-antibody Diluent.</li> <li>HRP-avidin (1×) - Centrifuge the vial before opening.<br/>HRP-avidin requires a 100-fold dilution. The suggested dilution is 10µL of HRP-avidin + 990µL of HRP-avidin Diluent.</li> <li>Wash Buffer (1×) - If crystals have formed in the concentrate, warm up to room temperature and mix gently until the crystals have completely dissolved. Dilute 20mL of Wash Buffer (1×).</li> <li>Standard - Centrifuge the standard vial at 6000-10000rpm for 30s.<br/>Reconstitute the Standard with 1ml of Sample Diluent. Do not substitute other diluents.
