	(1:3000) is used as preservative.

	In most cases the stop solution provided is 1 N H2SO4. The formulation of wash solution is
	proprietary information. None of the components contain (sodium) azide, thimerosal, 2-
	mercaptoethanol (2-ME) or any other poisonous materials. For the sandwich method kits, the

Protocol:	This assay employs the quantitative sandwich enzyme immunoassay technique. Antibody
	specific for GDF11 has been pre-coated onto a microplate. Standards and samples are pipetted
	into the wells and any GDF11 present is bound by the immobilized antibody. After removing any
	unbound substances, a biotin-conjugated antibody specific for GDF11 is added to the wells.
	After washing, avidin conjugated Horseradish Peroxidase (HRP) is added to the wells. Following
	a wash to remove any unbound avidin-enzyme reagent, a substrate solution is added to the
	wells and color develops in proportion to the amount of GDF11 bound in the initial step. The
	color development is stopped and the intensity of the color is measured.
Reagent Preparation:	Biotin-antibody (1×) - Centrifuge the vial before opening. Biotin antibody requires a 100 fold dilution. The suggested dilution is 10ul. of Biotin antibody.



	 HRP-avidin (1×) - Centrifuge the vial before opening.
	HRP-avidin requires a 100-fold dilution. The suggested dilution is 10µL of HRP-avidin + 990µL of HRP-avidin Diluent.
	 Wash Buffer (1×) - If crystals have formed in the concentrate, warm up to room temperature and mix gently until the crystals have completely dissolved. Dilute 20mL of Wash Buffer Concentrate (25×) into deionized or distilled water to prepare 500mL of Wash Buffer (1×). Standard - Centrifuge the standard vial at 6000-10000rpm for 30s. Reconstitute the Standard with 1ml of Sample Diluent. Do not substitute other diluents. This reconstitution produces a stock solution. Mix the standard to ensure complete reconstitution and allow the standard to sit for a minimum of 15 minutes with gentle agitation prior to making dilutions. Pipette 250µL of Sample Diluent into each tube. Use the stock solution to produce a 2-fold dilution series. Mix each tube thoroughly before the next transfer. The undiluted Standard serves as the high standard. Sample Diluent serves as the zero standard (0ng/mL).
	Note:
	 Kindly use graduated containers to prepare the reagent. Please don't prepare the reagent directly in the Diluent vials provided in the kit. Bring all reagents to room temperature (18-25°C) before use for 30 min. Prepare fresh standard for each assay. Use within 4 hours and discard after use. Making serial dilution in the wells directly is not permitted. Please carefully reconstitute Standards according to the instruction. Avoid foaming and mix gently until the crystals have completely dissolved. To minimize imprecision caused by pipetting, use small volumes and ensure that pipettors are calibrated. It is recommended to suck more than 10µL when pipetting. It is recommended to use distilled water to prepare reagents and samples. Using contaminated water or container for reagent preparation will influence detection result.

Handling Advice:	 The kit should not be used beyond the expiration date on the kit label. Do not mix or substitute reagents with those from other lots or sources. If samples generate values higher than the highest standard, dilute the samples with Sample Diluent and repeat the assay. Any variation in Sample Diluent, operator, pipetting technique, washing technique, incubation time/temperature and kit age can cause variation in binding. This assay is designed to eliminate interference by soluble receptors, binding proteins and other factors present in biological samples. Until all factors have been tested in the Immunoassay, the possibility of interference cannot be excluded.
