DO NOT subtract the O.D. of standard zero.</li> <li>Construct a standard curve by plotting the average O.D. for each standard on the vertical (Y) axis against the concentration on the horizontal (X) axis and draw a best fit curve using graph paper or statistical software to generate a four parameter logistic (4-PL) curve fit or logit log linear regression curve. An x-axis for the optical density and a y-axis for the concentration is also a choice. The data may be linearized by plotting the log of the concentrations versus the log of the 0.D. and the best fit line can be determined by regression analysis.</li> <li>Calculate the concentration of samples corresponding to the mean absorbance from the standard curve.</li> </ul>
