- Microtiter plates should be allowed to come to room temperature before opening the foil bags. Once the desired number of strips has been removed, immediately reseal the bag with desiccants and store at 2-8°C to maintain plate integrity.
- Samples should be collected in pyrogen/endotoxin-free tubes.
- Samples should be frozen if not analyzed shortly after collection. Avoid multiple freeze-thaw cycles of frozen samples. Thaw completely and mix well prior to analysis.
- When possible, avoid use of badly hemolyzed or lipemic serum. If large amounts of particulate matter are present, centrifuge or filter prior to analysis.
- When pipetting reagents, maintain a consistent order of addition from well-to-well. This ensures equal incubation times for all wells.

Information on standard material:

Different kits have different standards. For kits detecting proteisn or peptidse, the standards are recombinant proteins or synthetic peptides. For kits detecting small chemical compounds, the standards are synthetic chemical compounds. There are no standards extracted from natural resources. All of our reombinant proteins are expressed in E.coli. The standard are dissolved in PBS with 0.1 % proclin 300 and some other preservatives.

#### Information on reagents:

The STOP solution is 1M sulphuric acid. The wash buffer is 0.05 % Tween 20 in PBS, pH 7.4. The ELISA kit dose not contain (sodium) azide, thimerosal, 2-mercaptoethanol (2-ME). Part of the reagents contain BSA.

The provided antibodies and their host vary in different kits.

Protocol:	This ELISA kit applies the competitive enzyme immunoassay technique utilizing a monoclonal
	antibody for the target antigen and a target antigen HRP conjugate. The assay sample and
	buffer are incubated together with target antigen HRP conjugate in pre-coated plate for one
	hour. After the incubation period, the wells are decanted and washed five times. The wells are
	then incubated with a substrate for HRP enzyme. The product of the enzyme-substrate reaction
	forms a blue colored complex. Finally, a stop solution is added to stop the reaction, which will
	then turn the solution yellow. The intensity of color is inversely proportional to the target antiger
	concentration since the target antigen from samples and target antigen HRP conjugate
	compete for the antibody binding site. Since the number of sites is limited, as more sites are
	occupied by the target antigen from the sample, fewer sites are left to bind the conjugate. A
	standard curve is plotted relating the intensity of the color (0.D.) to the concentration of
	standards. The target antigen concentration in each sample is interpolated from this standard
	curve.
Reagent Preparation:	<ul> <li>Samples - Please predict the concentration before assaying. If concentrations are unknown or not within the detection range, a preliminary experiment is recommended to determine the optimal dilution. PBS (pH 7.0-7.2) or 0.9% physiological saline can be used as dilution buffer.</li> <li>Wash solution - Dilute 10mL of wash solution concentrate (100×) with 990mL of deionized or distilled water to prepare 1000mL of wash solution (1×). If crystals have formed in the concentrate, warm to room temperature and mix gently until the crystals have dissolved. The 1× wash solution is stable for 2 weeks at 2-8°C.</li> </ul>

Sample Collection:	<ul> <li>Serum: Use a serum separator tube and allow samples to clot for 2 hours at room temperature or overnight at 2-8°C. Centrifuge at approximately 1000 × g (or 3000rpm) for 15 minutes. Remove serum and assay immediately or aliquot and store samples at -20°C or - 80°C.</li> </ul>
	• <b>Plasma</b> : Collect plasma using EDTA or heparin as an anticoagulant. Centrifuge samples for 15 minutes at 100 × g (or 3000rpm) at 2-8°C within 30 minutes of collection. Assay immediately or aliquot and store samples at -20°C or -80°C.
	Tissue homogenates: The preparation of tissue homogenates will vary depending upon
	tissue type. For this assay, thoroughly rinse tissues in ice-cold PBS (0.02mol/L, pH 7.0-7.2) to
	remove excess blood and weigh before homogenization. Mince the tissues into small pieces
	and homogenize them in a certain amount of PBS with a glass homogenizer on ice. Subject
	the resulting suspension to ultrasonication or to two freeze-thaw cycles to further break

	• <b>Cell lysates</b> : Cells should be lysed according to the following directions.
	<ul> <li>1. Adherent cells should be detached with trypsin and then collected by centrifugation.</li> <li>Suspension cells can be collected by centrifugation directly.</li> <li>2. Wash three times in PBS.</li> </ul>

	<ul> <li>Construct a standard curve by plotting the average O.D. for each standard on the vertical (Y) axis against the concentration on the horizontal (X) axis and draw a best fit curve using graph paper or statistical software to generate a four parameter logistic (4-PL) curve fit or logit log linear regression curve. An x-axis for the optical density and a y-axis for the concentration is also a choice. The data may be linearized by plotting the log of the concentrations versus the log of the O.D. and the best fit line can be determined by regression analysis.</li> <li>Calculate the concentration of samples corresponding to the mean absorbance from the standard curve.</li> </ul>
